


Relative Spectral Sensitivity ^{1), 2)}


Photocurrent/Open-Circuit Voltage ^{1), 2)}

$I_p (V_R = 5 V) / V_O = f(E_e)$




Dark Current ^{1), 2)}






Dark Current ¹⁾





Notes
