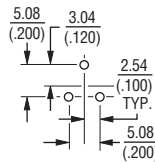

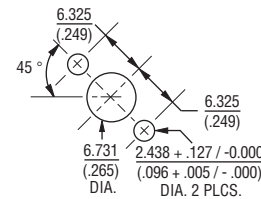

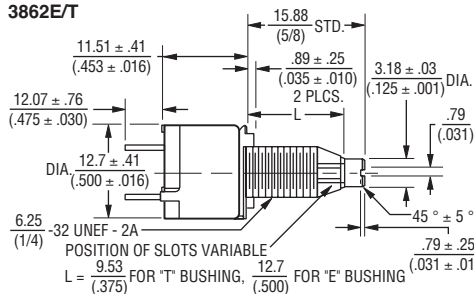
PCB LAYOUT



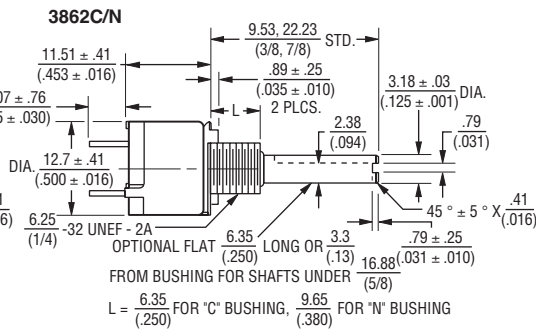

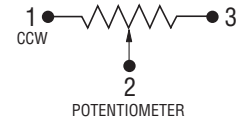
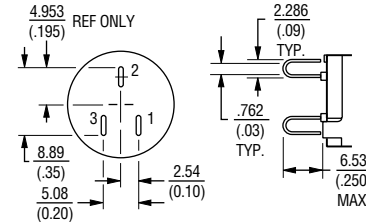
Shaft End Detail 3862



PC PIN TERMINAL



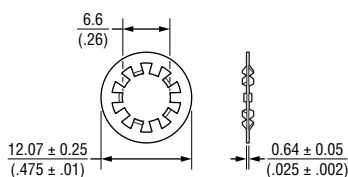
J-HOOK TERMINAL



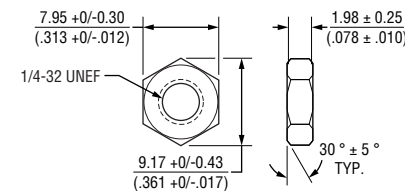

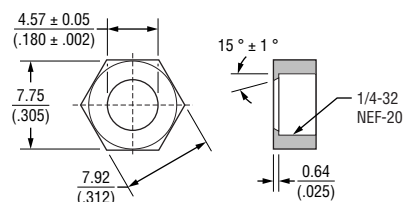

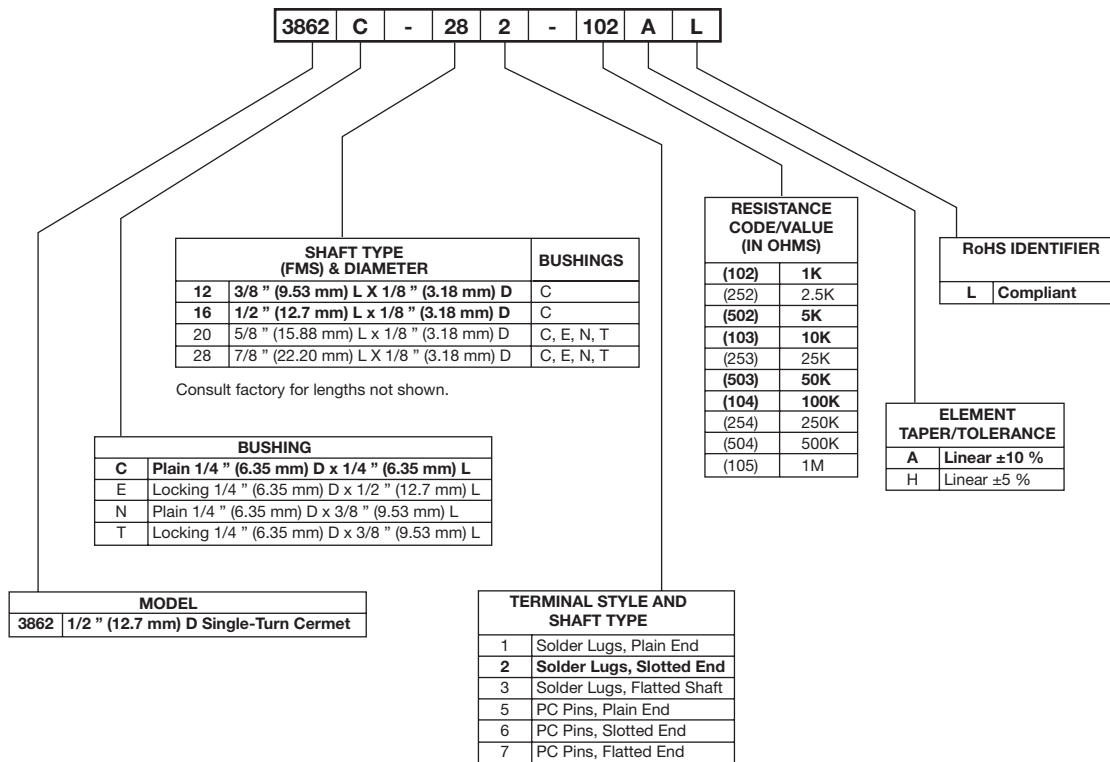
