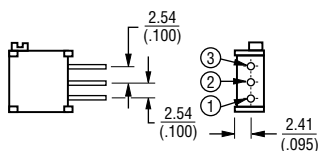

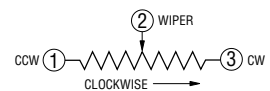

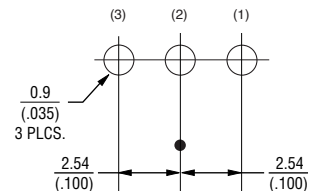

Schematic

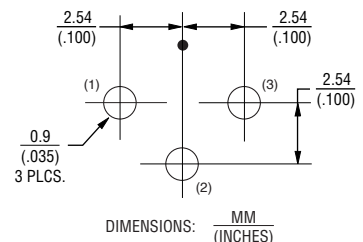


Recommended PCB Layout
