




Switch Configurations (Shown in Pulled Position)









SHAFT FLAT SHOWN AT 50 % OF MECHANICAL TRAVEL.




SUGGESTED PCB LAYOUT

PACKAGE DIMENSIONS WITH FRONT AND REAR PCB MOUNTING BRACKET






MM DIMENSIONS: (INCHES)


Anti-Rotation Lug




Terminal Layout



Electrical Schematic












