



PACKAGE DIMENSIONS W/PCB MOUNTING BRACKET





ANTI-ROTATION LUG (Style "A", 90 ° CW Shown)






SHAFT FLAT ORIENTATION






(Double Module Front and Rear Bracket Shown)


Suggested Panel Layouts



Electrical Schematic




Switch Configuration






Terminal Layout






